## H.C.A.P. Elections for year 2023-2026

## **Guideline for the Candidates**

- Each eligible member can contest for any one post & can keep only one elected post in one tenure.
- 2. For Contesting H.C.A.P. elections, the candidates should have at least 3 years of membership experience as a life member of HCAP as on last date of nominations i.e. 05<sup>th</sup> September 2023 for the post of Joint Secretary and EC Members and 5 years for President, Vice -President, General Secretary, and Treasurer.
- 3. The nomination fees cum security amount is mandatory for all the contestant for each and every post the security money will be as per below;

The nomination fees cum security amount will be submit in the form of Cheque in favor of "Haryana Chartered Association of Physiotherapist (Regd.)" payable at Rohtak. Along with nomination form to the office of Returning officer on or before 05<sup>th</sup> September 2023.

- 4. The nomination fees cum security amount is refundable but the amount will be seized if any candidate is fail to get minimum twenty percent of total vote count.
- 5. The nomination form along with your self-attested copy of Aadhar card, your HCAP membership certificates and all the other required documents should be submitted to the Returning officer's office by the last date of nominations i.e. 05<sup>th</sup> September 2023 upto 05:00 pm. Any nomination form received after this given time limit will be count as null & void & cannot be consider.
- 6. Nomination form, not completely filled as per the requirements is likely to be rejected.
